III. CONSIDERATION OF OCTOBER 4, 2010, MINUTES

Following review and consideration of the October 4, 2010, meeting minutes, the minutes were ratified.

IV. REPORTS

A. Program Director Report

Ms. Duran introduced the new member of the Advisory Committee, Dr. Tahl Humes.

Dr. Humes briefly addressed the Committee and gave a brief description of her background.

B. Examination Vendor Updates

Tim Lambert, Operations Manager with Pearson VUE provided the following updates:

1. After a six State review of the practical exam content, a core element was changed. Beginning January 3, 2011, the practical examination is based on the thought that one client is receiving many services. The previous test scored each step individually as a "new procedure and a new client." And required cleaning and disinfecting to occur throughout the examination. The new testing procedure has been well received and applicants appear to be happy to see the change.
2. Pearson VUE tested 2,500 applicants in 2010 and issued 1,800 licenses. The deficiency rate of application was approximately 30%.
3. Pearson VUE's applicant satisfaction survey produced a 95% satisfaction rate.

C. Review of Outreach and Education Update

During the period of October 3, 2010, through December 7, 2010, the Office staff provided training and instruction to 220 professional participants at six venues.

V. NEW BUSINESS

A. Designation of Meeting Notice Location.

During the first Advisory Committee meeting of each year, the location of posting of the notices must be designated. The Division Director designated

B. Dermaplane Discussion

The summary on dermaplaning was reviewed. A lengthy discussion followed among the committee members. Key points included: Scope of practice, safety, injury treatment, education and training and whether the service required a Medical Director based on the Board of Medical Examiners Rule 800.

Ms. Duran will work with the Attorney General's Office in reviewing the law and provide a recommendation to the committee once additional research is completed.

C. Consumer Guide

A consumer guide was developed and presented to the committee to educate the public about what to expect when receiving services and what is allowed in the professional's scope of practice. The guide will be available on-line as an additional resource for consumers.

D. National-Interstate Council of State Boards of Cosmetology Boards (NIC) Bulletin

Two news bulletins were reviewed and discussed. Ms. Duran indicated that the information sharing between regulating bodies is beneficial to those who administer. Ms. Duran is planning to attend the NIC annual meeting August 2011.
