

## **APPLICATION FOR LICENSE BY ENDORSEMENT/RECIPROCITY—ELECTRICIAN**

### **APPLICANT INSTRUCTIONS**

**NEW License Renewal Requirements.** Beginning January 1, 2011 new renewal requirements apply to your license. Important details are available online at [www.dora.state.co.us/electrical/cc](http://www.dora.state.co.us/electrical/cc).

**Mandatory Practice Act.** Colorado has a mandatory practice act, which means that you may not practice as an Electrician in this state without a Colorado license. Submission of this application does not guarantee licensure. Therefore, do not make life or career decisions based on the probability that you may receive a license. Plan ahead for the time it will take for us to receive all required documents and complete our evaluation.

**About the Application.** This application is to be completed by you and returned to the Office of Licensing. All questions on the application are mandatory, and all supporting documents must be submitted with the application. You may copy as many forms as needed; however, each form submitted must be completed in original ink or typed. Keep a copy of the completed application for your records.

**Basic Requirements for Licensure by Endorsement/Reciprocity.** Licensees from another state may be eligible for licensure by endorsement provided that the applicant possesses credentials and qualifications that are substantially equivalent to requirements in Colorado for original licensure by examination. If you do not qualify for Endorsement, you must use the Original License by Examination application, available online at [www.dora.state.co.us/electrical/licensing.htm](http://www.dora.state.co.us/electrical/licensing.htm).

**License by Endorsement.** If you answer “no” to any of the following questions, you do not qualify for license by endorsement and must take the examination in Colorado:

- Is the license from the state in which you took the exam a state-issued license?
- Have you taken an exam based on the current or immediately previous edition of the National Electrical Code (NEC) in effect in Colorado at the time of your application?
- Is the license current in the state where you took the examination?

**Reciprocal License.** For journeyman electrician licenses only, Colorado has entered into reciprocal licensing agreements with the following states: Alaska, Arkansas, Minnesota, Montana, Nebraska, New Hampshire, New Mexico, North Dakota, Oklahoma, South Dakota, Utah, and Wyoming. Applicants are required to submit an application, fee, and a copy of the qualifying license. New Mexico applicants: See Applicant Checklist for additional information.

**Application Expiration.** Your application will be kept on file for one (1) year from date of receipt in the Division of Registrations. Your file and all supporting documentation will be purged if you do not submit required documents and complete your application process in one year. You will need to resubmit a new application packet and fee after that time.

- If you submitted an application within the last year and were notified that you did not meet the requirements and you are submitting an update, you do not need to complete a new application or submit additional fees.

**Social Security Number is Required.** Effective January 1, 2009, a Social Security Number is required for all licensees. The Division will consider an application to be incomplete when the applicant fails to submit his/her Social Security Number. Exceptions are made for foreign nationals not physically present in the United States and for non-immigrants in the United States on student visas who do not have a Social Security Number. These applicants must submit a signed Social Security Number Affidavit in lieu of a Social Security Number. You may call (303) 894-7800 to request that an affidavit be mailed to you.

**Disclosure of Addresses.** Consistent with Colorado law, all addresses and phone numbers on record with the Division are public record and must be provided to the public when requested. It is your responsibility to keep your address and contact information up-to-date in our database. All letters, renewal notices, and licenses are mailed to the last known address of record. **If your address is not current, it is possible you will not receive important documents.** You can change your address online by using Registrations Online Services at [www.doradls.state.co.us](http://www.doradls.state.co.us).

## APPLICANT INSTRUCTIONS (Continued)

**Checking Your Application Status.** Visit Registrations Online Services at [www.doradls.state.co.us](http://www.doradls.state.co.us) to track your application from the date we log it in our database to the date your license is printed. Please allow us enough time to receive the application through the mail and enter your application into our database before you check the website. We recommend waiting at least 10 business days from date of mailing before checking the status of your application.

**License Expiration Grace Period for New Applicants.** Applicants who are issued an electrician license within 120 days of the upcoming expiration date will be issued a license with the subsequent expiration date. For example, licenses issued between June 1, 2011, and September 30, 2011, will reflect a license expiration date of September 30, 2014.

- Electrician licenses expire on September 30 of each renewal year and must be renewed to continue practicing.

In 2011, new legislation affecting electrician license renewal requirements took effect. As part of this new legislation, electrician licenses changed to a 3-year renewal cycle coinciding with the adoption of a new National Electrical Code (NEC) every three years (i.e., in 2011, 2014, 2017, etc.).

## APPLICANT CHECKLIST

**To apply for a Master Electrician license by Endorsement, Residential Wireman license by Endorsement, or Journeyman license by Endorsement if you are not currently licensed in a reciprocal state:**

- Submit a completed Application for License by Endorsement/Reciprocity.** Return the completed application and all supporting documentation to the Office of Licensing.
- Enclose the non-refundable application processing fee.** See page 1 of the application form for current fees. Fees may be paid by a check or money order drawn in U.S. dollars on a U.S. bank and made payable to *State of Colorado*. All fees are non-refundable and subject to change every July 1.
- Complete and return the attached Affidavit of Eligibility form.** Pursuant to C.R.S. 24-34-107, all applicants for licensure are required to complete and sign an Affidavit of Eligibility, and may also be required to provide a copy of a secure and verifiable document.
- Provide documentation of any name change.** If your name has changed since you obtained a previously-issued license, or if your name is different on any of your supporting documentation, you must provide a copy of the legal document verifying the name change (i.e., marriage license, divorce decree, or court order).
- Provide a copy of a qualifying license from another state.** Note: if you meet the qualifications for Colorado license by endorsement in multiple states, you only need to submit information from one state.
- Request verification of examination and licensure requirements from that state.** Send the attached License Verification Request to the state in which you are licensed. Have the state complete and return the Verification form to you. Include the completed Verification form with original signature and state seal or stamp in your application package.
- Document your experience and work history on the attached Affidavit of Experience.**

You must submit verification of the minimum experience requirements with your application. **All experience obtained after July 1, 2005, must be verified on the form provided with this application (Affidavit of Experience).** No other letters of verification will be accepted for experience gained after that date. **For experience obtained before July 1, 2005,** the Board will accept letters from the employer. Letters verifying experience from before July 1, 2005, must be on original company letterhead (photocopies will not be accepted) and must include the following information:

- Dates of employment – month, day, and year
- The total hours or months worked
- A breakdown of the experience (in either hours, months, or percent of total time worked) in each area such as residential wiring, commercial/industrial, planning and layout, maintenance, etc. The specific types of maintenance must be detailed by the employer.
- The letter must be dated and signed by a representative of the company.

### **To apply for a Journeyman Electrician license by Reciprocity if you are currently licensed in a reciprocal state:**

- Submit a completed Application for License by Endorsement/Reciprocity.** Return the completed application and all supporting documentation to the Office of Licensing.
- Enclose the non-refundable application processing fee.** See page 1 of the application form for current fees. Fees may be paid by a check or money order drawn in U.S. dollars on a U.S. bank and made payable to *State of Colorado*. All fees are non-refundable and subject to change every July 1.
- Complete and return the attached Affidavit of Eligibility Form.** Pursuant to C.R.S. 24-34-107, all applicants for licensure are required to complete and sign an Affidavit of Eligibility, and may also be required to provide a copy of a secure and verifiable document.
- Provide documentation of any name change.** If your name has changed since you obtained a previously-issued license, or if your name is different on any of your supporting documentation, you must provide a copy of the legal document verifying the name change (i.e., marriage license, divorce decree, or court order).
- Provide a copy of the qualifying license from the reciprocal state** (see Applicant Instructions above for the list of states with which Colorado has reciprocal license agreements for the journeyman license only).
  - **Note to New Mexico applicants:** You must have taken an exam on the current or immediately previous edition of the National Electrical Code (NEC) in effect in Colorado at the time of your application.

**SUBJECT:** Licensure and Criminal History

Thank you for your interest in becoming a licensed\* professional within the Division of Registrations. Before you submit your application, please be aware of a few facts regarding criminal conduct, convictions, and disciplinary actions in other states.

The mission of the Division of Registrations is “public protection through effective licensure and enforcement.” One way the Division safeguards consumers is by issuing licenses to fully qualified, competent, and ethical applicants.

During the licensing process – and depending on the specific application – the Division will ask whether you have ever been disciplined in any state, arrested, charged, convicted, or pled guilty to a crime. An arrest, subsequent criminal conviction, or disciplinary action is not an automatic disqualification from licensure. Instead, the appropriate board or program will look at the facts surrounding the criminal conduct and disciplinary action to determine whether you are fit for licensure. You should know that licensure is a privilege, not a right. One thing you must do to obtain the privilege is to be completely honest on your application.

Be sure to list all relevant complaints, disciplinary actions, arrests, charges, or convictions in response to the licensure questions. Failure to fully disclose could constitute grounds alone for denial of your application or revocation of your license. More important, avoid some of the common excuses we have heard from people who failed to disclose, such as:

- My attorney told me I didn’t have to disclose the criminal conduct or disciplinary actions.
- I didn’t think the prior conduct had anything to do with the profession.
- I didn’t think the disciplinary action, arrest, charges, or conviction was still on my record.
- I didn’t think it was subject to disclosure because I received a deferred sentence/judgment.

Remember, there is no excuse not to disclose disciplinary actions and criminal conduct. Even after licensure, you are still required to notify your professional licensing board or program about subsequent convictions and disciplinary actions in other states.

The Division conducts audits of its licensing database against several criminal and national disciplinary databases. This allows the Division to verify the truthfulness of your application and track subsequent criminal and disciplinary conduct after initial licensure. Keep in mind, you will not necessarily be revoked or denied a license if you have been disciplined, arrested, charged or convicted, but you will most likely be denied or revoked if you fail to disclose it.

## WORK EXPERIENCE DEFINITIONS

### RESIDENTIAL

Includes new construction, remodeling and additions to buildings for residential occupancy (one, two, three, and four-unit family dwellings). Also include apartment buildings, condominiums, and townhouses. Work done within all residential units will receive residential credit. Work done in common areas such as laundry rooms, corridors, rec. rooms, etc. will receive commercial credit. **DO NOT** include mobile park service facilities.

### COMMERCIAL

Includes new construction remodeling and additions to stores, office buildings, gas stations, theaters, mobile home park supply, irrigation pumps, warehouses, hospitals, and other buildings and facilities of a similar nature.

### INDUSTRIAL

Includes remodeling, additions and new construction of manufacturing plants of all types.

### MAINTENANCE

Includes all time spent in repairing, replacing and taking care of existing electrical facilities.

### PLANNING AND LAYOUT OF ELECTRICAL WORK
