\*\*\*Conditional Approval- A program may be placed on conditional approval status if the Board determines that the program does not meet all of the provisions contained in the Rules and Regulations related to educational programs. Conditional approval allows the program to continue to operate while correcting deficiencies and working to return to full approval.
