New Rule in Effect

Rosemary McCool, the Division Director, has adopted rule D.18. on behalf of the Office of Outfitters Registration. This rule defines "emergency situation" and lays out the requirements for an outfitter who needs to hire a guide without a valid first aid card. The rule is effective November 30, 2006.

Registrations Online Services

New Renewal Calendar

Once you successfully renew your registration this year, you will notice that the expiration date of your new registration is March 31, 2008. Effective with the current renewal, all outfitters registrations will expire each year on March 31. We hope that this new renewal date will help alleviate some of the problems many have had with the December renewal date.

Update Your Mailing Address

All licensees must keep their mailing address updated with the Office of Outfitters Registration. Pursuant to Rule B.7, an outfitter shall notify the Division, in writing, within 30 days of any change of your mailing address (business or residence).

Renewal notices are mailed to the last known address on file approximately six (6) weeks prior to the expiration date. Failure to receive your notice does not relieve you from the obligation to timely pay the renewal fee and complete renewal before your registration expires.

Registrations Online Documents (ROD), found at www.dora.state.co.us/registrations/ROD.htm, is a website that allows the consumer to view images of scanned documents through the Internet. In reviewing a licensee's information, it is important to know what is and is not available.

If applicable to the licensee, the following information WOULD appear on a record under Board or Program Actions:

1. If a licensee had been disciplined or formally accused of wrongdoing by the Board or Program.
2. If the Board or Program has taken some other non-disciplinary action against the licensee that restricts or limits the individual's license.

Board/Program Action Documents available via Registrations Online Documents (ROD):

- All **Stipulations, Final Agency Orders, and Suspensions** that were in effect in February 2000 plus any that became effective since that date. Child support suspensions are not available online but may be obtained by contacting the appropriate Board.
- Any document **Revoking** or agreeing to a **Voluntary Relinquishment/Surrender** of license or registration, **Cease and Desist Orders** and **Letters of Admonition** from January 1, 1999 to the present.
- All **Injunctions**.
- All **Notice of Charges** or **Formal Complaints**, if the information is a public record, for cases that were pending hearing as of February 2000.
- **Jury verdicts** against a physician or physician assistant in a civil medical liability trial that occurred after August 3, 2004.
