I. BY THE COMMISSION

A. Statement

1. This matter comes before the Commission for consideration of approval of 24 Corrective Action Plans (CAP) that were submitted by the metro Denver area Regional Transportation District light rail operation that occurred between July 1, 2022 and September 30, 2022. A report summarizing the CAP was filed by Staff of the Public Utilities Commission (Staff) on January 11, 2023.

2. The CAP numbers reviewed by the Commission are: CAP01-11112021, CAP02-11112021, CAP03-11112021, CAP04-12282021, CAP05-12282021, CAP06-12282021, CAP07-02112922, CAP08-02112022, CAP09-03022022, CAP10-03022022, CAP11-03022022, CAP12-03022022, CAP01-07272022, CAP02-07272022, CAP03-07272022, CAP04-07272022, CAP05-07272022, CAP06-07272022, CAP07-07272022, CAP08-07272022, CAP1-08052022, CAP01-09212022, CAP02-09212022 and CAP1-09262022 for final approval and monitoring to closure.

3. This matter also comes before the Commission for consideration of two CAP's that Staff has monitored and verified that all CAP elements have been completed as outlined in the CAPs and as discussed in the report summarizing the CAP's filed by Staff on January 18, 2023. The CAP numbers reviewed by Commission for closure are: CAP1-02242020 and CAP2-11132020.

4. The Commission has reviewed the summary report filed by Staff and concurs with Staff's review of the CAPs and recommendations for final approval and monitoring to closure of the 24 new CAPs, and for closure of two existing open CAPs.

5. The Commission has jurisdiction in this matter under § 40-18-103, C.R.S., and Rule 7347 of the Rules Regulating Railroads, Rail Fixed Guideways, Transportation by Rail, and Rail Crossings, 4 *Code of Colorado Regulations* 723-7.

II. ORDER

A. The Commission Orders That:

The Commission provides final approval of and monitoring to closure CAP01-11112021, CAP02-11112021, CAP03-11112021, CAP04-12282021, CAP05-12282021, CAP06-12282021, CAP07-02112922, CAP08-02112022, CAP09-03022022, CAP10-03022022, CAP11-03022022, CAP12-03022022, CAP01-07272022, CAP02-07272022, CAP03-07272022, CAP04-07272022, CAP05-07272022, CAP06-07272022, CAP07-07272022, CAP08-07272022, CAP1-08052022, CAP01-09212022, CAP02-09212022 and CAP1-09262022 submitted by the metro Denver area Regional Transportation District light rail operations and closure of CAP1-02242020 and CAP2-11132020.
