I. **BY THE COMMISSION**

> Α. Statement, Discussion, and Findings

Rule 3206(c) of the Commission's Rules Regulating Electric Utilities, 4 Code of 1.

Colorado Regulations (CCR) 723-3, requires each Colorado electric utility to file with the

Commission, no later than April 30 of each year, information on its proposed new construction or

extensions of transmission facilities for the next three calendar years. Rule 3206(d)(II)(B)

directs Commission Staff (Staff) to review the filings and comments, and to make

recommendations to the Commission by July 1.

2. Through Decision No. C23-0434, issued July 6, 2023, the Commission extended

the deadline for Staff to make recommendations to the Commission to August 3, 2023.

3. We provide for a further variance from Rule 3206(d)(II)(B) and Decision No. C23-0434, on our own motion, and extend the deadline for Staff to make recommendations in this proceeding to September 27, 2023.

II. ORDER

A. It Is Ordered That:

- 1. On the Commission's own motion, a variance is provided from the August 9, 2023 deadline for Staff to provide recommendations in this Proceeding.
- 2. Staff shall make recommendations to the Commission by **September 27, 2023,** unless modified by future order.
