I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a filing submitted on June 18, 2024, by Boilesen Shuttles LLC, doing business as Sweet Pea Tours (“Applicant”), requesting the Commission grant an extension of 60 days to comply with the terms of Decision No. C24-0245 (“Decision”).

2. On February 28, 2024, Applicant filed an Application for permanent authority to extend operations under its Certificate of Public Convenience and Necessity (“CPCN”) PUC No. 48202S.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on March 4, 2024. This proceeding was uncontested; and thus, it was determined without a hearing.

4. On April 19, 2024, the Commission issued the Decision and granted the Application, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.

5. Ordering Paragraph No. 3 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit an advice letter with tariff; and register with the Commission's electronic filing system.

6. The Decision gave Applicant 60 days from its effective date of April 19, 2024, to comply with each of these requirements. For good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

7. On June 18, 2024, Applicant timely filed the instant request for an extension of 60 days to comply with the Decision. Applicant states that this request is "due to unplanned international travel."

8. The Commission concludes that good cause exists to grant Applicant's request for an extension of 60 days to comply with the Decision.

II. ORDER

A. The Commission Orders That:

1. The filing submitted by Boilesen Shuttles LLC, doing business as Sweet Pea Tours, on June 18, 2024, requesting that the Commission grant an extension of 60 days for it to complete the requirements set forth in Decision No. C24-0245, is granted.

2. Boilesen Shuttles LLC, doing business as Sweet Pea Tours, is granted 60 days from the Issued Date of this Decision to comply with the requirements set forth in Decision No. C24-0245.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an Application for Rehearing, Reargument, or Reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Issued Date.
