I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On June 20, 2024, Boulder Transport LLC, doing business as Boulder Transport, filed an application to abandon operations under Contract Carrier Permit No. B-10058.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on June 24, 2024, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the information submitted with this application warrants the granting of the requested abandonment.

5. This Application for approval to abandon Contract Carrier Permit No. B-10058 is not contrary to the public interest and will be granted.

II. ORDER

A. The Commission Orders That:

- 1. This Application was deemed, within the meaning of § 40-6-109.5, C.R.S.
- 2. The Application filed by Boulder Transport LLC, doing business as Boulder Transport, for approval to abandon operations under Contract Carrier Permit No. B-10058, is granted.
 - 3. Contract Carrier Permit No. B-10058 is CANCELLED.
- 4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an Application for Rehearing, Reargument, or Reconsideration shall begin on the first day after the Commission mails or serves this Decision.

- 5. This Decision is effective on its Issued Date.
