**INTERIM COMMISSION DECISION GRANTING
UNOPPOSED MOTION FOR AN EXTENSION OF TIME
TO FILE REPORT**

I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. Public Service filed its 2023 Renewable Energy Standard Compliance Report on May 31, 2024. Pursuant to Commission Rule 3663(a)(III), Commission Trial Staff's recommendations were due within 60 days of the filing, or July 30, 2024.

2. On July 19, 2024, Trial Staff filed an unopposed motion to extend the time to file its report by 45 days, to September 13, 2024.

3. On September 13, 2024, Trial Staff filed its second Unopposed Motion for Extension of Time. The motion requests to extend the deadline for Trial Staff to file its report by 14 days, to September 27, 2024. Trial Staff also requests that we waive response time to the motion.

4. In support of its request, Trial Staff reports that due to the number of concurrent proceedings it has been unable to finalize its review of Public Service's report. It further indicates

that the 14-day extension of time will allow Trial Staff to complete the review and provide the Commission with the most accurate information after properly validating the information contained in Public Service's report.

5. Moreover, Trial Staff indicates that it conferred with all parties to the proceeding and no responding party indicated that it opposed the extension. No responses in opposition to the motion have been received.

6. Because the relief is unopposed to find good cause to waive remaining response time to the motion. Additionally, for the reasons put forth by Trial Staff we find good cause to grant a variance to Rule 3663(a)(III) and paragraph II(A)(3) of Interim Decision C24-0532-I and thereby approve a 14-day extension of the deadline to September 27, 2024.

II. ORDER

A. It Is Ordered That:

1. Trial Staff's Unopposed Motion for an Extension of Time to File its Report Regarding Public Service Company of Colorado's Renewable Energy Standard Compliance Report and Request for Waiver of Response Time, is granted.

2. This Decision is effective on its Issued Date.
