COMMISSION ORDER GRANTING TEMPORARY AUTHORITY

STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

- 1. On April 30, 1992, Randy Johnson, doing business as A-1 Drain & Septic Co., filed Docket No. 92A-177BY-TA for temporary authority to conduct operations as a contract carrier by motor vehicle for hire for the transportation of sludge, from the facilities of Excel Corporation in the County of Morgan, State of Colorado, to Sections 1 and 12 of Township 4 North, Range 58 West and to Section 7 of Township 4 North, Range 57 West. This application is restricted to providing service for only Excel Corporation.
- 2. An intervention opposing the application was filed by Liquid Waste Management, Inc. (LWM) on May 4, 1992.
- 3. By \$ 40-6-120, C.R.S., the application for temporary authority is under consideration for a Commission order.
- 4. Section 40-6-120(1), C.R.S., authorizes the Commission to grant temporary authority when there appears to be ". . . an immediate

and urgent need to any point or within a territory having no carrier service capable of meeting such need."

- 5. The support filed on behalf of this application indicates that the supporting shipper, Excel, is located in the County of Morgan, State of Colorado. Excel has a need to have its sludge transported to agricultural areas in northeast Colorado. Excel further states that it is now producing product and must have the sludge removed in order to keep the plant functioning and operational. The intervention of LWM states that it has been providing service to Excel until recently. It has transported the sludge to points outside Morgan County. Additionally, LWM states that Morgan County just recently adopted rules regarding the disposal of sludge on farm land in the County. LWM's intervention states that it will obtain the requisite permits from the County within a few weeks. On May 22, 1992, the Commission's Staff contacted the Northeastern Colorado Health Department. According to that agency, LWM had not applied for the required permits as of that date.
- 6. Apparently the Applicant is the only company authorized by the Morgan County Health Department to dispose of sludge in Morgan County. The intervenor, although holding proper PUC authority, presently does not have the health department permits. Although LWM made the statement to the Commission on May 4, 1992 that it would obtain the proper Morgan County permits it had not made application 18 days later. Therefore, the Commission will grant the temporary authority.
- 7. The Applicant has adequate equipment and financial resources to begin immediate service within the scope of the authority sought and is willing, ready, and able to operate under all Commission rules and regulations governing carriers by motor vehicle.
- 8. This application for temporary authority is in the public interest and should be granted.
- 9. The Applicant is strongly advised that the granting of an temporary authority makes no presumption that permanent authority will be granted.

THEREFORE THE COMMISSION ORDERS THAT:

1. Randy Johnson, doing business as A-1 Drain & Septic Co., is granted temporary authority to conduct operations as a contract carrier for a period of 165 days commencing from the mailed date of this Order, with authority as set forth in the attached appendix.
