STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

- 1. On June 26, 1992, Administrative Law Judge Ken Kirkpatrick entered Recommended Decision No. R92-831. This decision recommends that the operating authority of Edwin R. Havener (Havener) be revoked for failure to maintain continuous liability insurance as required by Rule No. 12 of the Commission's Rules and Regulations Governing Common Carriers by Motor Vehicle. The effective date of the recommended decision was July 16, 1992.
- 2. On July 16, 1992, Havener filed a motion to stay the effective date of the recommended decision. As grounds for the motion, Havener states that he presently has insurance and that no harm will befall the public by the stay. The Commission's records do reflect that a current certificate of insurance is on file. Good cause having been shown, the Commission will grant the stay for 30 days and allow Havener time to file exceptions to the decision.
