# COMMISSION ORDER GRANTING TEMPORARY AUTHORITY

## STATEMENT, FINDINGS, AND CONCLUSIONS

### BY THE COMMISSION:

- 1. On September 8, 1992, Jeffrey Jon Giberson, doing business as Executone Express, filed Docket No. 92A-407BY-TA for temporary authority to conduct operations as a contract carrier by motor vehicle for hire for the transportation of books, galleys, manuscripts, interoffice correspondence, mail, checks, money orders, bank drafts, computer tapes, computer printouts, computer supplies and equipment, audio visual equipment, camera equipment, and art work between all points in the County of El Paso, State of Colorado. Restricted to providing service for only Shepard's McGraw Hill, Inc.
- 2. The Commission gave notice of the application on September 14, 1992.
- 3. By \$ 40-6-120, C.R.S., the application for temporary authority is under consideration for a Commission order.
- 4. Section 40-6-120(1), C.R.S., authorizes the Commission to grant temporary authority when there appears to be ". . . an immediate

and urgent need to any point or within a territory having no carrier service capable of meeting such need."

5. The support filed on behalf of this application indicates that shipper needs a daily, scheduled courier service, using dedicated equipment and a dedicated driver performing the service each day. Having the same driver perform the service each day will insure, for shipper, the driver's familiarity with the pickups and deliveries necessary for shipper.

The shipper has conducted its own research of carrier, courier services within El Paso County, and found that its needs cannot be satisfied. No other courier will provide the same driver daily, and no other courier will dedicate its equipment and service to the shipper's needs.

- 6. The Commission finds due to the facts stated in paragraph 5 above, there is as immediate and urgent need for additional transportation services. The Commission will grant the application.
- 7. The Applicant has adequate equipment and financial resources to begin immediate service within the scope of the authority sought and is willing, ready, and able to operate under all Commission rules and regulations governing carriers by motor vehicle.
- 8. This application for temporary authority is in the public interest and should be granted.
- 9. The Applicant is advised that the granting of an temporary authority makes no presumption that permanent authority will be granted.

### THEREFORE THE COMMISSION ORDERS THAT:

- 1. Jeffrey Jon Giberson, doing business as Executone Express, is granted temporary authority to conduct operations as a contract carrier by motor vehicle for hire for a period of 180 days commencing from the mailed date of this order, with authority as set forth in the attached Appendix.
- 2. Jeffrey Jon Giberson, doing business as Executone Express, shall not commence operation until all requirements have been met and notice in writing has been received from the Commission that the Applicant is in compliance and may begin service.

3. The 20-day time period provided by \$ 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsid-eration shall begin on the first day after the Commission mails or serves this decision.
