**I. BY THE COMMISSION:**

**Statement, Findings, and Conclusion**

As a result of the passage of the Airport Improvement Bill of 1994, signed by the President on August 26, 1994, and subsequently upheld on appeal by the Federal District Court for the State of Oklahoma, state regulation over the rates, routes, and service of carriers of property has been preempted. Accordingly, this application has been rendered moot by supervening federal legislation. Applicant does not need a contract carrier permit from this Commission to engage in the transportation of property in intrastate commerce anywhere in the State of Colorado. However, Applicant must continue to comply with the Commission's rules relating to insurance and safety.

**II. ORDER**

**A. The Commission Orders That:**

1. The hearing set for January 3, 1995 is hereby vacated.

2. The application of Moon Enterprises, Ltd is dismissed without prejudice.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
