**I. BY THE COMMISSION:**

**A. Statement, Findings, and Conclusion**

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. Also at that time, this matter was set for hearing before the Commission on July 27, 1995.

2. No protest, objection, or petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is therefore noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without an oral hearing.

3. To grant the request for suspension of Part (B) of Certificate of Public Convenience and Necessity PUC No. 47049 would be in the public interest.
4. The evidence submitted warrants the approval of suspension of Part (B) of Certificate of Public Convenience and Necessity PUC No. 47049 as here ordered.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The hearing set for July 27, 1995 is hereby vacated.
2. This application was deemed complete on June 29, 1995, within the meaning of § 40-6-109.5.
3. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 47049 is authorized by the Commission from May 9, 1995 through November 30, 1995.
4. On or before September 30, 1995, Applicant shall file a written request either for an extension of this suspension period, or a request to reinstate Certificate of Public Convenience and Necessity PUC No. 47049. Prior to reinstatement, insurance and tariffs shall be filed. The failure to file a written request either for an extension of suspension or reinstatement of the certificate and filing of insurance and tariffs

will result in revocation of the authority without  
further notice.

**B.** This Order is effective on its Mailed Date.
