### A.Statement, Findings, and Conclusion

- 1. Proper notice of the filing of this application has been given under \$40-6-108(2)\$, C.R.S. Also at that time, this matter was set for hearing before the Commission on May 12, 1995.
- 2.No protest, objection, or petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is therefore noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without an oral hearing.

- 3. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 41889 is authorized by the Commission from April 20, 1995 through November 1, 1995.
- 4.On or before September 1, 1995, the Applicant shall file a written request either for an extension of this suspension period, or a request to reinstate Certificate of Public Convenience and Necessity PUC No. 41889.

  Prior to reinstatement, insurance and tariffs shall be filed. The failure to file a written request either for an extension of suspension or reinstatement of the certificate and filing of insurance and tariffs will result in revocation of the authority without further notice and without the right to reinstatement.
