## I.BY THE COMMISSION:

### A.Statement, Findings, and Conclusion

- 1. Proper notice of the filing of this application has been given under \$40-6-108(2)\$, C.R.S. Also at that time, this matter was set for hearing before the Commission on September 28, 1995.
- 2.No protest, objection, or petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is therefore noncontested. Under § 40-6-109(5), C.R.S., this matter may be deter-mined without an oral hearing.

- 3.Applicant has requested to suspend the authority for a period of six months from the effective date of this Order.

- 1. The hearing set for September 28, 1995 is hereby vacated.
- 2. This application was deemed complete on August 24, 1995, within the meaning of \$ 40-6-109.5.
- 3. The suspension of motor vehicle operations under Certificate of

  Public Convenience and Necessity PUC No. 45394 is

  authorized by the Commission for a period of up to

  six months from the effective date of this Order.
- 4.On or before December 22, 1995, Applicant shall file a written request either for an extension of this suspension period, or a request to reinstate Certificate of Public Convenience and Necessity PUC No. 45394.

  Prior to reinstatement, insurance and tariffs shall

be filed. The failure to file a written request either for an extension of suspension or reinstatement of the certificate and filing of insurance and tariffs will result in revocation of the authority without

further notice. **B.**This Order is effective on its Mailed Date.
