I.BY THE COMMISSION:

A.Statement, Findings, and Conclusion

- 1. This application was filed on November 21, 1995, by Applicant, Denver Airport Limousine Service, Inc., doing business as Denver Airport Shuttle ("DASH"). By this application, DASH sought to extend its common carrier operations under Certificate of Public Convenience and Necessity PUC No. 82.
- 2. On January 24, 1996, the application was granted pursuant to Recommended Decision No. R96-90. On February 8, 1996, prior to Decision No. R96-90 becoming final, Certificate No. 82 was transferred to Denver Shuttle, LLC (Decision No. C96-141).
- 3. Decision No. R96-90 expressly granted DASH 60 days from the effective date of the Decision to comply with issuance requirements of said order. On March 15, 1996, Denver Shuttle, LLC, timely filed a notice of substitution of parties. The extension of operations

under PUC No. 82, and the change of ownership of said certificate, have both been approved by the Commission. An administrative name change to the certificate would therefore be legally possible; however, we find that for the purpose of historical record keeping, a Commission Decision recognizing the substitution of parties is more appropriate to an administrative change.

- 4. In addition, Denver Shuttle, LLC, on May 3, 1996, completed a name change and adopted the following trade names: Denver Airport Shuttle and/or Super Shuttle Denver and/or Super Shuttle Airport Shuttle.
- 5. The Commission Staff shall reissue Certificate No. 82 to Denver Shuttle, LLC, doing business as Denver Airport Shuttle and/or Super Shuttle Denver and/or Super Shuttle Airport Shuttle.

II.ORDER

A. The Commission Orders That:

1. The full and complete authority under Certificate of Public Convenience and Necessity PUC No. 82 shall be set forth in the attached Appendix, and shall forthwith be reissued to Denver Shuttle, LLC, doing business as Denver Airport Shuttle and/or Super Shuttle Denver and/or Super Shuttle Airport Shuttle.

 - V.Transportation of passengers and their baggage, on schedule, between all hotels and motels within the City and County of Denver, State of Colorado, on the one hand, and the Colorado Springs Municipal Airport, Colorado Springs, Colorado, on the other hand, serving all intermediate points on and within two miles of Interstate 25, between Denver

and the Colorado Springs Municipal Airport, and serving all points located on and within one mile of Interstate 225 as off-route points.
