I.BY THE COMMISSION:

Statement, Findings, and Conclusion

1. On October 18, 1996, Shannon Buchanan and Jean Mahan, doing business as Wild Irish Roses, filed an application (Docket No. 96A-474CP-TA) for temporary authority to conduct operations as a common carrier by motor vehicle for hire for the transportation of passengers and their baggage, in call-and-demand limousine service, between all points in the Counties of Adams, Arapahoe, Boulder, Denver, Jefferson, and Weld, State of Colorado. This application is restricted to the transportation of passengers that are 60 years of age or older.

2. The Commission gave notice of the application on November 4, 1996. Interventions opposing a grant of the application were filed by Denver Taxi, LLC, doing business as Yellow Cab, and/or Super Shuttle 1-800 BLUE VAN; Boulder Taxi, LLC, doing business as Boulder Yellow Cab; and Denver Shuttle, LLC, doing business as Super Shuttle Airport Shuttle; and, Golden West Commuter, LLC. The Commission also received a protest from Janice Weaver, doing business as Viking Taxi.

3. By § 40-6-120, C.R.S., the application for temporary authority is under consideration for a Commission order.

4. Pursuant to § 40-6-120(1), C.R.S., the Commission is authorized to grant temporary authority when there appears to be an immediate and urgent need to any point or within a territory having no carrier service capable of meeting such need.

5. The burden of proof created by this statute is indeed heavy. The Applicant must meet a two-fold test in order to satisfy the criteria demanded by the law. First, that there is an immediate and urgent need for the transportation services, and second, that there is no existing carrier capable of meeting the need. If the Applicant fails to meet either test, the application cannot be granted.

6. Though the Applicant wishes to restrict its proposed services to individuals 60 years of age or older, its request still directly overlaps the services provided by many of the carriers who have intervened into this matter.

7. This application for temporary authority does not meet the criteria demanded by the law, and should be denied.

II.ORDER:

A.The Commission Orders That:

1. This application is denied.
