STATEMENT, FINDINGS, AND CONCLUSIONS

On January 12, 1994, the staff of the Commission served audit questions and request for production of documents to TFG,

Denver Transportation, Inc., d/b/a Yellow Cab of Denver; Boulder Transportation, Inc., d/b/a Yellow Cab of Boulder; and Denver Airport Express, Inc., d/b/a Denver Airport Express, Inc., (collectively TFG group). On January 18, 1994, the TFG group filed Objection to Audit Requests and Motion for Protective Order.

On January 26, 1994, Staff of the Colorado Public Utilities Commission (Staff) filed Response to Objection to Audit Requests and Motion for Protective Order. By such response, Staff withdraws the audit questions submitted to the applicants on or about January 12, 1994.

In view of the above withdrawal of Staff's audit questions, the applicants' objection to Audit Requests and Motion for Protective Order is moot and will be dismissed.

<u>ORDER</u>

IT IS ORDERED THAT:

1. The Objections to Audit Requests and Motion for Protective Order, filed on January 18, 1994, by the TFG group, is moot and is dismissed.
