I. BY THE COMMISSION

Statement

- 1. The Colorado Public Utilities Commission gives notice of proposed rulemaking regarding new Rules pertaining to an appeal process pursuant to § 29-20-108, C.R.S., that allows a public utility to appeal local government siting and building determinations for power plants and other facilities to the Public Utilities Commission in certain circumstances. A public utility may appeal a local government land use decision if the local decision will impair the ability of the public utility to provide safe, reliable, or economical service to the public and if the utility meets certain requirements as enumerated in § 29-20-108, C.R.S.
- 2. A copy of the new Rules is attached to this notice of proposed rulemaking. The statutory authority for the

proposed Rules is found within §§ 24-4-101, et seq., 29-11-106, 29-20-108, 40-2-108, and 40-5-101, et seq., C.R.S.

3. The Commission will conduct a hearing on the proposed rules and related issues at the below stated time and place. Interested persons may submit written comments on the rules and present these orally at hearing, unless the Commission deems oral presentations unnecessary. The Commission will also receive comment on the need for the new rules or whether current Rule 4 CCR 723-1-70 will accommodate the new procedures. The Commission also encourages interested persons to submit written comments before the hearing scheduled in this matter. In the event interested persons wish to file comments before the hearing, the Commission requests that such comments be filed ten days prior to the hearing date. The Commission will consider all submissions.

II. ORDER

A. The Commission Orders That:

- 1. This Notice Of Proposed Rulemaking shall be filed with the Colorado Secretary of State for publication in the November 10, 2001 edition of <u>The Colorado Register</u>.
