This filing is made in compliance with Decision No. C03-XXXX, Consolidated Docket No. XXX-XXX, granting Qwest's application for tariff changes on less than statutory notice. This decision also approves a Stipulation and Settlement Agreement that authorizes Qwest Corporation to eliminate zone charges effective August 1, 2003. In conjunction with the elimination of zone charges, the Low-Income Telephone Assistance Program credits and Tribal Lifeline credits associated with zone charges have also been eliminated. In addition, textual changes have been made to remove references to zone charges.

The Stipulation and Settlement agreement approved in this decision would allow Qwest to recover revenue lost from eliminating zone charges (approximately \$21.7 million) through a series of events including, an increase in funding (approximately \$10.7 million) from the 2003 Colorado High Cost Support Mechanism ("CHCSM") effective upon the elimination of zone charges, said increase having been previously approved in Docket No. 98M-236T, Decision No. C03-0709. To facilitate the elimination of zone charges, Qwest has agreed to forego approximately \$6.4 million of lost revenue between August 1, 2003 and March 31, 2004. On April 1, 2004, Qwest will begin receiving additional CHCSM support to recover the balance of lost revenue on a going-forward basis, or in the alternative will increase rates, on a revenue-neutral basis, to offset the elimination of zone charges. The Stipulation and Settlement agreement also amends the existing LNP Stipulation in order to provide additional funding to offset the revenue shortfall resulting from the elimination of zone charges.

This filing is made in conjunction with Qwest Corporation's Transmittal No. xxx.

A. Colorado Low-Income Telephone Assistance Program

1. Definition

The Colorado Low-Income Telephone Assistance Program provides for a discount of the recurring monthly rate for the provision of local residential service for certain low-income customers.

2. Eligibility

- a. The Colorado Low-Income Telephone Assistance Program discount is only available to low-income customers who meet eligibility requirements established by Colorado Revised Statute 40-3.4 and are certified for eligibility by the Colorado Department of Human Services. Applicants are eligible for this program if they currently receive benefits from at least one of the following Human Services programs: Old Age Pension, Aid to the Blind, Aid to the Needy Disabled or are low income disabled persons who qualify to receive supplemental security income under the federal "Social Security Act" (as amended). The Colorado Department of Human Services shall periodically recertify an individual's eligibility to receive low-income telephone assistance.
- b. The monthly discount to eligible subscribers will be a 25% discount on the exchange service offerings listed below. The discount provided will not be less than the Federal Communications Commission subscriber line charge.

 - Measured Rate Service
 - Message Rate Service
 - Service Station Service

B. Tribal Lifeline With Federal Credits

1. Description

Tribal Lifeline provides additional lifeline support of up to \$25.00, in addition to the baseline Federal Lifeline support of \$8.25 for qualifying low-income individuals living on or near tribal lands which includes reservation and near reservation as defined by the Bureau of Indian Affairs (BIA) regulations. Near reservation, means those areas or communities adjacent or contiguous to reservations designated as such by the BIA.

2. Terms and Conditions

- a. Residents of tribal lands who qualify for Lifeline based on the requirements listed below are eligible for the Tribal Lifeline benefit if they participate in one or more of the following programs:
 - Bureau of Indian Affairs general assistance program,
 - Tribally administered Temporary Assistance for Needy Families block grant program,
 - Head Start programs (only for those meeting its income-qualifying standard),
 - National School Lunch Program's free lunch program.
- b. The Company must obtain the customers signature on a document in which the eligible customer certifies, under penalty of perjury, that such customer receives benefits from at least one of the programs above, and lives on or near a reservation. In addition to identifying the program or programs from which that customer receives benefits, the customer must also agree to notify the Company if that customer ceases to participate in the qualifying program or programs.
- c. Tribal Lifeline benefits apply to the primary flat local residential access line, including Extended Area Service (EAS), mileage charges, or other non-discretionary charges associated with basic residential service. The benefit may not bring the basic local residential access line rate below \$1.00 per month.

The Stipulation and Settlement agreement also amends the existing LNP Stipulation in order to provide additional funding to offset the revenue shortfall resulting from the elimination of zone charges.
