- 1. Decision No. C03-1166 failed to include the thirty days further suspension provided in previous Decision No. C03-1032, in the calculation of the further suspension date of this Decision. Decision No. C03-1032 further suspended the effective date of tariffs to November 28, 2003.
- 2. Correct Decision No. C03-1166 by calculating the ninety days further suspension of this Decision from November 28, 2003, that is, unto February 26, 2004. Specifically, correct Decision No. C03-1166 by appending the following sentence to ¶ I.A.1.:

On August 28, 2003, the Company filed its Amended Advice Letter No. 1394 changing the proposed effective date of the accompanying tariffs to July 31, 2003. In response to the change in proposed effective date by the Company's filing of Amended Advice Letter No. 1394, the Commission issued Decision No. C03-1032, further suspending the effective date of tariffs for 30 days, until November 28, 2003.

3. Correct Decision No. C03-1166 in ¶ I.A.2 and ¶ I.A.3. and Ordering ¶ II.A.1. by replacing occurrences of "January 27, 2004" with "February 26, 2004" so that the last sentence of ¶ I.A.2 reads:

Thus, the Commission has the power and authority to suspend the effective date of the tariffs for a maximum of 210 days or, in this docket, until **February 26**, **2004**.

- and so that ¶ I.A.3. reads:
 - 3. The Commission finds that in order to complete its review of the tariffs, it must further suspend the proposed tariffs for an additional 90 days or until **February 26, 2004**, because the rates contained in the tariffs may be improper.

and so that Ordering ¶ II.A.1. reads:

1. The effective date of the tariffs filed by Public Service Company of Colorado, on May 30, 2003 are further suspended for an additional 90 days or until **February 26, 2004**.
