I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On September 25, 2003, Colorado Mobility, Inc., record owner of Contract Carrier

Permit No. B-9810, filed an application for approval to permit Vladimir Saud to transfer all of

the permanent issued and outstanding shares of capital stock in Colorado Mobility, Inc., to Lev

Zotman.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on October 6, 2003. The Commission set this

matter for hearing on December 5, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

- 4. The information submitted with this application warrants the grant of the requested stock transfer.
  - 5. The financial standing of Lev Zotman has been satisfactorily established.
- 6. Lev Zotman, as a controlling shareholder, is ready, willing, and able to properly perform the duties to ensure continued adequate operations under Contract Carrier Permit No. B-9810.
- 7. This application for approval to permit Vladimir Saud to transfer all of the issued and outstanding shares of capital stock in Colorado Mobility, Inc., to Lev Zotman is in the public interest.

## II. ORDER

## A. The Commission Orders That

- 1. The hearing set for December 5, 2003, is vacated.
- 2. This application was deemed complete on November 7, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Colorado Mobility, Inc., record owner of Contract Carrier Permit No. B-9810, for approval to permit Vladimir Saud to transfer all of the permanent issued and outstanding shares of capital stock in Colorado Mobility, Inc., to Lev Zotman is granted.
- 4. Lev Zotman may not consummate the approved stock purchase transaction until an acceptance of stock transfer signed by Vladimir Saud and Lev Zotman is filed with the Commission, and written notification has been received from the Commission that it is in compliance and may begin service.

- 5. If Vladimir Saud and Lev Zotman do not comply with the requirements of this Order within 60 days of its effective date, then the approval to transfer stock of Colorado Mobility, Inc., record owner of Contract Carrier Permit No. B-9810, shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.
  - 6. This Order is effective immediately on its Mailed Date.
