STIPULATED MOTION FOR IMPOSITION OF RESTRICTIVE AMENDMENT AND CONDITIONAL WITHDRAWAL OF INTERVENTION OF METRO TAXI, INC. IN DOCKET NO. 02A-642BP-EXT

Metro Taxi, Inc., (Metro Taxi or Intervenor), by and through its attorney, Charles M. Williams, of Charles M. Williams, P.C., and Admired Transportation, Inc. (Admired or Applicant), by and through attorney, Charles J. Kimball of Kimball & Nespor, P.C., file the above stipulated motion with the Colorado Public Utilities Commission (Commission or PUC). In support thereof the parties state as follows:

I. Applicant seeks the following authority in its permanent authority application:

For authority to extend operations under Contract Carrier Permit No. B9814 to include the transportation of passengers and their baggage as follows: (I) between all points within the Counties of Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson, and Larimer, State of Colorado; and (II) between all points within the Counties of Adams, Arapahoe, Boulder,

Broomfield, Denver, Douglas, Jefferson, and Larimer, State of Colorado. This application is restricted as follows: (1) Item (I) is restricted to providing transportation service for only Jefferson County Department of Social Services, 900 Jefferson County Parkway, Golden, Colorado 80401; and (2) Item (II) is restricted as follows: (A) to providing services for only Arapahoe County Community Services Department, (B) to providing services under the Medicaid, General Medical, and Older Americans Act Programs of the Arapahoe County Community Services Department; (C) against providing transportation which originates or terminates at Denver International Airport; and (D) to the use of a total of six vehicles.

A copy of the PUC Notice of the Application is attached hereto as Exhibit 1. A copy of the existing permit of Admired is attached hereto as Exhibit 2. By this application Admired seeks to add Boulder, Broomfield, and Larimer Counties to the permit and to provide service to the Jefferson County Department of Social Services as a contracting customer between all points in the Counties of Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson and Larimer, State of Colorado.

- II. Intervenor opposes this application, alleging a material interest in said proceeding.
- III. Applicant has reviewed its application, the needs of its supporting witnesses, the services it proposes to render under the authority sought in said application, and the intervention of Metro Taxi. Applicant now finds that by restricting its application as set forth herein, Applicant can eliminate the interests of Intervenor without impairing its ability to perform the services envisioned by this application. Accordingly, Applicant hereby moves to restrictively amend its application to eliminate that part of the application seeking to serve Jefferson County Department of Social Services (Part I of the application as noticed). If the amendment is accepted by the Commission, the authority sought in this application would be redefined as follows:

Transportation of passengers and their baggage, between all points in the area comprised of the Counties of Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson, and Larimer, State of Colorado.

RESTRICTIONS:

- 1. Restricted to providing services for only the Arapahoe County Community Services Department.
- 2. Restricted to providing services under the Medicaid, General Medical, and Older Americans Act Programs of the Arapahoe County Community Services Department.
- 3. Restricted against providing transportation which originates or terminates at Denver International Airport.
- 4. Restricted to the use of a total of six vehicles.

The parties believe that the proposed amendments are restrictive in nature, and do not require renotice.

- IV. Applicant and Intervenor respectively and respectfully urge the Commission's acceptance of the restrictive amendments set forth in Paragraph III above. Acceptance of the restrictive amendments would eliminate the interests of Metro Taxi and eliminate its need to expend additional resources in pursuit of its intervention in this proceeding. Eliminating the interests of Intervenor would lessen time spent at hearing.
- V. Upon the Commission's finding the restrictive amendments set forth in Paragraph III above to be administratively acceptable, and accepting them in the form submitted, Metro Taxi's intervention can be deemed withdrawn. In the event the offered restrictive amendments are not accepted, or are accepted in a form other than as submitted, Metro Taxi specifically does not withdraw its intervention and gives notice to its intent to continue its opposition to the application.


