**INTERIM ORDER OF

ACCEPTING CONDITIONAL WITHDRAWAL**

I. STATEMENT

1. On June 27, 2005, MEYLO, LLC, doing business as Big Sky Transport Shuttle (Big Sky) and RDSM Transportation, LTD., doing business as Yellow Cab Company of Colorado Springs (RDSM or Yellow Cab) filed their Stipulated Motion to Restrict Authority and Conditional Withdrawal of Intervention (Motion). The stipulation proposes amendments to the Application, which, if accepted by the Commission, would result in the withdrawal of RDSM's intervention.

2. By Decision No. R05-0922-I (mailed date of July 27, 2005), the Administrative Law Judge (ALJ) accepted the restrictive amendment as a modification to the territorial scope of the authority proposed in the Motion, but further expressed concerns that the authority stated appears to seek an extension of authority duplicating existing authority, in contradiction of *Rule 4, 4 Code of Colorado Regulations CCR 723-31*.

3. Considering the form of relief granted, the Conditional Withdrawal of RDSM was deferred, affording an opportunity to seek reconsideration or modification of the Interim Order. The ALJ now decides the request for Conditional Withdrawal.

4. The acceptance of the restriction upon the territorial scope of authority sought by Big Sky satisfies the expressed concerns of Yellow Cab. It is appropriate for Yellow Cab to withdraw its intervention, considering it no longer opposes the application, as amended. In accordance with Yellow Cab's statement, its intervention is deemed withdrawn; *i.e.*, Yellow Cab's withdrawal will be granted.

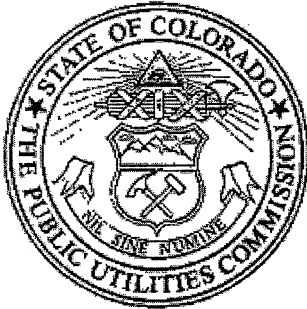
II. ORDER

A. It Is Ordered That:

1. The Conditional Withdrawal of Intervention filed jointly by Applicant MEYLO, LLC, doing business as Big Sky Transport Shuttle, and RDSM Transportation, LTD., doing business as Yellow Cab Company of Colorado Springs, is granted, accepting the withdrawal of intervention by RDSM Transportation, LTD.

2. This Order is effective immediately.
