Rocky Company is proposing that the Tariff revisions proposed by this filing become effective on September 1, 2006.

In this filing, and after discussion of the matter with Commission Staff, Rocky Company is not proposing a change to the Tariff provision addressing minimum Btu requirements. If deemed necessary and appropriate, Rocky Company will file a request for a waiver of the requirements of Rule 4202 of the Commission's Rules Regulating Gas Utilities and Pipeline Operators.

The Statement of Nature, Reasons and Basis attached hereto as Attachment A provides a detailed statement of the Tariff revisions proposed by Rocky Company by this filing and an explanation for each substantive revision proposed.

The tariff sheets accompanying this 2nd Amended Advice Letter No. 55 comply with the requirements of Rule 4109 of the Commission's Rules Regulating Gas Utilities and Pipeline Operators. Attachment B hereto includes redlined versions of each Tariff Sheet of Volume No. 2 proposed to be revised by this filing, showing the revisions made to each sheet.

The clean versions of the filed tariff sheets do not reflect use of the symbols set forth on Sheet No. 4. The red-lined tariff sheets provided with this filing show all changes made to the clean tariff sheets, thereby providing more information than that disclosed by the use of the symbols. If deemed necessary and appropriate, Rocky Company requests that the Commission grant a waiver of the requirements of Sheet No. 4, and the corresponding provisions of the Commission's Rules Regulating Gas Utilities and Pipeline Operators.


