Dawn Food Products, Applicant herein, and Union Pacific Railroad Company, Intervenor herein, hereby enter into this Stipulation and Settlement Agreement and in consideration of all of the terms and conditions set forth herein, hereby agree and stipulate as follows:

1. This case was filed on September 18, 2006 by Dawn Food Products to seek a permanent variance of the PUC rule related to side clearances to allow a side clearance of 8'1", rather than the required 8'6" and to achieve a variance of the horizontal clearance requirements to allow a horizontal clearance of 7' 2 1/4", rather than the required clearance of 8' -1".
2. Union Pacific filed an intervention in this case on October 26, 2006 on the grounds that the clearance variances requested do not meet Union Pacific requirements.
3. Union Pacific representatives have met on site with Mr. Young of Dawn Foods. Mr. Young has proposed a compromise that would revise the location of the three lighted "restricted clearance" signs. The attached Exhibit "A" is the letter from Mr. Young, along with two pages of drawings that illustrate the clearances and the location of the various signs.
4. Union Pacific has no objection to the granting of the variances so long as the requirements and placement shown in the three pages of Exhibit A are followed.
5. Dawn Foods, by this stipulation agrees to abide by the requirements of Exhibit A.
6. Dawn Foods and Union Pacific hereby request that the Commission enter an order approving the variance request as modified by the terms of this stipulation.
7. This Stipulation shall not become effective until the Commission issues an order approving the Stipulation, which order does not contain any modification of the terms and conditions of this Stipulation that is unacceptable to either of the parties to the Stipulation. In the event the Commission modifies this Stipulation in a manner unacceptable to either party hereto, that party may withdraw from the Stipulation and shall notify the Commission and the other party to the Stipulation in writing within ten (10) days of the date of the final Commission order. In the event a party exercises


its right to withdraw from the Stipulation, the Stipulation shall be null and void and have no effect.


8. In the event this Stipulation becomes null and void, or in the event the Commission does not approve this Stipulation, this Stipulation as well as the negotiations undertaken in conjunction with this Stipulation shall not be admissible into evidence in any proceeding.
9. The parties state that they have reached this Stipulation by means of a negotiated process that is in the public interest and that the results reflected in this Stipulation are just, reasonable and in the public interest.
10. This Stipulation may be executed in separate counterparts, including facsimile. The counterparts taken together shall constitute the Stipulation. The parties represent that the signatories to this Stipulation shall have full authority to bind their respective parties to the terms of this Stipulation.
11. The Stipulation shall be governed by and construed in accordance with the laws of the State of Colorado.
