The principal proposed change is: to revise the Service and Facility

The principal proposed change is: to revise the Service and Facility Charge portion of the Monthly Rate section of the Transmission General Service ("Schedule TG") in the Company's Colorado P.U.C. No. 7 - Electric tariff.

Pursuant to the Electric Service Agreement ("Agreement") dated July 13, 2011 between Public Service Company of Colorado and the United States Department of State the Company will provide electric service at transmission voltage to the Denver Federal Center substation site.

By this advice letter, the Company proposes to add the Service and Facility Charge for the Department of State at the Denver Federal Center and substation site to the Company's TG rate schedule. The monthly Service and Facility Charge to the Denver Federal Center and substation site is \$3,400.00. The amendment to the Areawide Public Utility Contract between the Company and the United States of America for the State of Colorado Contract No. GS-00P-06-BSD-0385 labeled Exhibit A is attached hereto. This filing will bring to date the Commission's contract file.

The effect of this filing upon the Company's annual base rate revenues is an increase of approximately \$326,196 based on estimated usage data for twelve months ending August 31, 2012.

It is desired that the changed tariff accompanying this advice letter become effective September 1, 2011.
