I. BY THE COMMISSION

A. Statement

1. In accordance with Rule 2846 of the Rules Regulating Telecommunications Providers, Services, and Products, 4 *Code of Colorado Regulations* (CCR) 723-2, each Eligible Provider (EP) receiving support pursuant to Rule 2848 must provide to the Administrator a verified accounting of: (1) the actual number of residential and business access lines served by such provider in each exchange as of the last day of each month; and (2) the actual amount of contributions collected in the month if the provider applies the rate element to its end user customer. This data shall be submitted to the Administrator by the 15th day of the subsequent quarter.

2. In accordance with Rule 2846 of 4 CCR 723-2, each wireless EP receiving support pursuant to Rule 2848 shall provide to the Administrator a verified accounting of:

(1) the actual number of residential and business wireless handsets served by such provider in each exchange as of the last day of each month; and (2) if the provider applies the rate element to its end user customer, then it shall report the actual amount of contributions collected in the month. The data shall be submitted to the Administrator by the 15th day of the subsequent quarter.

3. Each EP receiving high cost support is required to file data for its residential and business access line counts, or wireless handset counts, for each applicable exchange. All filings made in accordance with Rule 2846 shall be made in an executable format by the 15th day of the subsequent quarter.

4. An EP receiving high cost support pursuant to Rule 2848 may file a motion for a reasonable extension of time in this docket if it cannot meet the filing deadline.

5. This Order specifies the data to be filed by each EP receiving high cost support in the format specified in Appendix A to this Order. The reporting form may be found on the Commission's website at www.dora.state.co.us/puc.

II. **ORDER**

A. **The Commission Orders That:**

1. Each Eligible Provider receiving support pursuant to Rule 2846 of the Rules Regulating Telecommunications Providers, Services, and Products, 4 *Code of Colorado Regulations* (CCR) 723-2 shall file its residential and business access line counts, or wireless handset counts, and amount of high cost contributions collected in accordance with Rule 2846(b)(II) in an executable format on or before the 15th day of each subsequent quarter.

2. An Eligible Provider may file a motion for a reasonable extension of time in this docket if it cannot meet the filing deadline.

3. This Order is effective upon its Mailed Date.
