I. <u>BY THE COMMISSION</u>

A. Statement

1. This matter comes before the Commission for consideration of a request filed on December 30, 2013 by Colorado Springs Transportation, doing business as Yellow Cab Company of Colorado Springs (YCCS), to shorten the Commission notice period to ten days (Shortened Notice Request). The Shortened Notice Request was submitted concurrently with YCCS's Petition for a Waiver/Variance (Petition) from Commission Rules 723-6-6255(a)(III)-(VII) of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* (CCR) 723-6.

B. Findings and Conclusions

Through the Shortened Notice Request, YCCS seeks to shorten notice from
30 days to 10 days from the date the Commission issues the notice of the Petition.

3. In support of its Shortened Notice Request, YCCS states that the Petition has been discussed with Commission Transportation Staff in advance. YCCS also states that the other taxi companies affected by Rules 6255(a)(III)-(VII) are having similar difficulties achieving

compliance and are likely to request waivers as well, and that the interested parties are therefore unlikely to have any objections.

4. Rule 1401(a) of the Commission's Rules of Practice and Procedure, 4 CCR 723-1 states "Except as provided by paragraph (d) of this rule, any person may file a notice of intervention as of right or a motion to intervene by permission within 30 days of notice of any administrative or adjudicatory proceeding, unless the Commission's notice or a specific rule or statute provides otherwise."

5. Rule 1003(a) provides that:

The Commission has promulgated these rules to ensure orderly and fair treatment of all persons. The Commission may, for good cause shown, grant waivers or variances from tariffs, Commission rules, and substantive requirements contained in Commission decisions. In making its determination the Commission may take into account, but is not limited to, considerations of hardship, equity, or more effective implementation of overall policy on an individual basis.

6. We find that good cause exists to grant YCCS's shortened notice request. The reason for the shortened notice request, and the requested time period are reasonable. The Petition will be placed on the next transportation notice, on January 13, 2014, for a period of ten days. Interventions shall be due at **5:00 p.m. on January 23, 2014**.

II. <u>ORDER</u>

A. It Is Ordered That:

1. The request by Colorado Springs Transportation, doing business as Yellow Cab Company of Colorado Springs to shorten Commission notice is granted. The notice period for the Petition for Waiver/Variance from Commission Rules 723-6-6255(a)(III)-(VII), 4 *Code of Colorado Regulations* 723-6, shall extend through and including **5:00 p.m. on January 23**, **2014.** 2. Any person desiring to intervene or participate as a party in this proceeding, including Staff of the Commission, shall file a petition for leave to intervene, or under the Commission's Rules of Practice and Procedure, file other appropriate pleadings to become a

party, by 5:00 p.m. on January 23, 2014.
