The purpose of this advice letter filing is to modify the Company's natural gas distribution rates in the Eastern Colorado Division rate area. This change is made in conformance with PUC Recommended Decision No. R13-1090 and Decision No. C13-1304 adopted on October 16, 2013 in Proceeding No. 13AL-0153G. The original rate case testimony and estimates for the Eastern Colorado Division upgrade were for a total or maximum of \$2,961,856 to be added to the Eastern system rate base which led to a distribution rate for the Eastern rate area of \$0.3360 per therm effective November 1, 2013. Following the actual work and reporting due December 2, 2013, the expenditures totaled \$2,285,479 a variance from estimate of (\$676,377) that creates a distribution rate of \$0.3079 per therm, which is a reduction of (\$0.0281) per therm.
