I. BY THE COMMISSION

> Α. Statement

This matter comes before the Commission for consideration of a letter filed on 1.

February 6, 2014, by Mohamed Radi, the owner of Disability Transport Line LLC (Transport

Line) requesting that the Commission grant an additional 90 days to comply with the terms of

Recommended Decision No. R13-1456 (Decision).

B. **Findings**

2 On September 18, 2013, Transport Line filed an application for authority to

operate as a contract carrier by motor vehicle for hire for the transportation of Medicaid

recipients in non-medical transportation for the Colorado Department of Health Care Policy and

Financing.

3 The Commission noticed the application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on September 23, 2013. One intervention was

filed against the application; that intervention was subsequently withdrawn and the application

was granted on November 22, 2013 by the Decision.

- 4. The Decision approved the application for contract carrier authority. The Decision also set forth certain requirements to be completed prior to the commencement of operations.
- 5. Specifically, Ordering Paragraph No. 7 of the Decision states that Transport Line shall not commence operation until the following conditions are met:

Applicant shall not commence the operations under the permit until it has complied with the requirements of Colorado laws and Commission rules, including without limitation:

- (a) causing proof of insurance (Form E or self-insurance) or surety bond (Form G) coverage to be filed with the Commission;
- (b) paying to the Commission, the motor vehicle fee (\$5) for each vehicle to be operated under authority granted by the Commission or, in lieu thereof, paid the fee for such vehicle(s) pursuant to the Unified Carrier Registration Agreement;
- having an effective tariff on file with the Commission. Applicant shall file an advice letter and tariff on not less than ten days' notice. The advice letter and tariff shall be filed as a new Advice Letter proceeding and shall comply with all applicable rules. In calculating the proposed effective date, the date received at the Commission is not included in the notice period and the entire notice period must expire prior to the effective date. (Additional tariff information can be found on the Commission's website at dora.colorado.gov/puc and by following the transportation common and contract carrier links to tariffs); and
- (d) paying the applicable issuance fee (\$5).
- 6. Furthermore, Ordering Paragraph No. 8 of the Decision states:

If Applicant does not cause proof of insurance or surety bond to be filed, pay the appropriate motor vehicle fees, file an advice letter and proposed tariff, and pay the issuance fee within 60 days of the effective date of this Decision, then the grant of the extended [sic] operations under the Permit shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within 60 days of the effective date of this Decision.

7. The Decision became effective 20 days after its mailing date, on December 12, 2013. Therefore, Transport Line had until February 10, 2014 to comply with the Decision or file a request for additional time. A request for additional time was timely filed on February 6, 2014.

8. In the letter filed on February 6, 2014, Mr. Radi states that his wife is having visa difficulties which require him to leave the country with her for a time, and he therefore requests an additional 90 days to file his compliance items.

C. Conclusions

9. The Commission concludes that Transport Line has shown good cause to extend the time for compliance with the requirements of the Decision for an additional 90 days from the original deadline of February 10, 2014.

II. ORDER

A. The Commission Orders That:

- 1. The request of Disability Transport Line LLC for the Commission to grant an additional 90 days for it to complete the requirements set forth in Decision No. R13-1456 filed on February 6, 2014, is granted.
- 2. Disability Transport Line LLC is granted until May 12, 2014 to complete the requirements set forth in Decision No. R13-1456.
- 3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
 - 4. This Decision is effective on its Mailed Date.
