I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

1. On May 22, 2014, Alpine Taxi/Limo Inc., doing business as Alpine and/or

GO Alpine, filed an application seeking authority to abandon a portion of Certificate of Public

Convenience and Necessity (CPCN) PUC No. 26246. The portion requested to be abandoned is

Item (XI) of the authority, which reads as follows:

Transportation of

passengers, on schedule,

between Steamboat Springs, Colorado, on the one hand, and Aspen and Vail, Colorado, on the other hand.

<u>RESTRICTION</u>:

All scheduled operations provided under Item (XI) are restricted to points named in the carrier's filed schedule.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on June 2, 2014.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. In accordance with Rule 6204 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the information submitted with this application warrants the granting of the requested partial abandonment.

5. The Commission finds that the application for authority to abandon a portion of CPCN PUC No. 26246 is in the public interest and will be granted.

6. CPCN PUC No. 26246 contains the antiquated term "limousine service." By Rule 6201, 4 CCR 723-6, which became effective August 1, 2012, the Commission adopted the term "shuttle service" to replace "limousine service." Therefore, the Commission finds good cause to revise CPCN PUC No. 26246 accordingly.

II. ORDER

A. The Commission Orders That:

1. This application was deemed complete on June 18, 2014, within the meaning of § 40-6-109.5, C.R.S.

2. The application filed by Alpine Taxi/Limo Inc., doing business as Alpine and/or GO Alpine, for approval to abandon a portion of Certificate of Public Convenience and Necessity PUC No. 26246 is granted as to the following portion:

(XI) Transportation of

passengers, on schedule,

between Steamboat Springs, Colorado, on the one hand, and Aspen and Vail, Colorado, on the other hand.

RESTRICTION:

All scheduled operations provided under Item (XI) are restricted to points named in the carrier's filed schedule.

3. Certificate of Public Convenience and Necessity PUC No. 26246 will be re-issued

to Alpine Taxi/Limo Inc., doing business as Alpine and/or GO Alpine, with the above-described

portion removed from the Certificate and the terminology changes noted in $\P 6$.

4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application

for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

5. This Decision is effective on its Mailed Date.
