I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

1. On July 3, 2014, Arrow Express LLC filed an application seeking approval to abandon operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55711.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on July 14, 2014.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. Pursuant to Rule 6204 of the Rules Regulating Transportation by Motor Vehicle,
4 *Code of Colorado Regulations* 723-6, the information submitted with this application warrants
the granting of the requested abandonment of CPCN PUC No. 55711.
