The purpose of this filing is to implement the passage of HB14-1331 which resulted in changes to the regulatory oversight for the products and services being provided by CenturyLink. Please note that the documents being filed did not modify the rates, terms or conditions, but rather established a new structure moving forward. The tariff will continue to contain fully regulated services, the catalog contains those services that continue to have some oversight so long as certain criteria remain in place and finally, the company has created a new document call the Local Terms of Service (LTS). In this document, the company moved the products, along with the terms and conditions that are no longer regulated by the Colorado Public Utilities Commission. The company created the LTS to ensure that our customers are able to navigate and understand the products and services the company provides.
