I. <u>BY THE COMMISSION</u>

A. Statement

- 1. This matter comes before the Commission for consideration of a Motion to Permit Late Intervention (Motion) filed by the Regional Transportation District (RTD) on September 16, 2014 requesting the Commission grant RTD permission to intervene in this proceeding at this stage, and to become a party to this proceeding.
- 2. As grounds, RTD states that it did receive service of the Notice of Application Filed electronically on August 5, 2014, but inadvertently overlooked the notice and discovered that the application was granted on September 12, 2014. RTD is affected by the application as it is one of the railroads over which the bridge structure replacement will be constructed and that it is in the interest of safety for RTD to receive notice of, and opportunity to participate in any further proceedings in this matter.

- 3. RTD states that because it does not oppose the application, its Motion does not prejudice the application.
 - 4. No responses were filed to the Motion.
 - 5. Now being fully advised in the matter, we grant the Motion.

II. ORDER

A. The Commission Orders That:

- 1. The Motion to Permit Late Intervention filed by the Regional Transportation District (RTD) on September 16, 2014 is granted.
 - 2. RTD shall be added as a party to this proceeding.
 - 3. The Commission retains jurisdiction to enter further decisions as necessary.
