**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. This matter comes before the Commission for consideration of a Motion for Extension of Time (Motion) filed on behalf of Voxbeam Telecommunications, Inc., doing business as Magic Telecom (Voxbeam or Company) on October 31, 2014.

2. In Decision No. C13-1476 (mailed December 2, 2013), the Commission granted Voxbeam's Application for a Certificate of Public Convenience and Necessity (CPCN) and Letter of Registration (LOR) with conditions. That Decision stated:

If Voxbeam fails to file an Advice Letter and accompanying proposed tariff that is effective within one year from the Mailed Date of this Decision, this CPCN to provide local exchange telecommunications services and LOR to provide emerging competitive telecommunications services shall be deemed null and void without further action of the Commission. For good cause shown, and if a proper request is filed within one year of the Mailed Date of this Decision, the Commission may grant Voxbeam additional time within which to file a tariff. [Per paragraph 8 of this Decision, Voxbeam is required to have an effective tariff on file no later than December 2, 2014.]

Concurrent with the filing of an Advice Letter and accompanying tariff, Voxbeam shall file a bond or letter of credit consistent with the terms and conditions attached to this Decision.

Decision No. C13-1476, Ordering ¶¶ 8 and 9.

3. In its Motion, the representative for Voxbeam states that the Company is in the process of obtaining a bond but it was unable to obtain it in time to file in accordance with the deadline set forth in the Commission's decision. The Company represented that it expected to obtain the bond no later than November 30, 2014.

4. With a financial bond in effect and filed with the Commission, Voxbeam will then be able to file its proposed tariffs. The Commission finds good cause exists to grant the Motion and waive response time thereto.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The Motion for Extension of Time to File an Advice Letter, Tariff, and Surety Bond, filed by Voxbeam Telecommunications, Inc., doing business as Magic Telecom (Voxbeam), is granted, and response time thereto is waived.

2. Voxbeam is granted an additional 60 days from December 2, 2014 to file its tariffs on not less than 30 days' notice to be effective by no later than February 2, 2015.

3. Concurrent with the filing of an Advice Letter and accompanying tariff, Voxbeam shall file a bond or letter of credit consistent with the requirements of Decision No. C13-1476.

4. This Decision is effective on its Mailed Date.
