I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

1. On December 19, 2013, Heart of the Rockies Tours LLC (Applicant) filed an application seeking authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55779 from December 16, 2013 through December 15, 2014.

 The application to suspend CPCN PUC No. 55779 from December 16, 2013 through December 15, 2014 was granted by Commission Decision No. C14-0079 on January 21, 2014.

3. On November 20, 2014, Applicant filed a Motion in this Proceeding requesting the suspension of CPCN PUC No. 55779 be ended as early as possible, as Applicant has been granted an application to lease CPCN PUC No. 55779 to Colorado Mount Express LLC, in Proceeding No. 14A-0749CP-LEASE.

4. Under § 40-6-112(1), C.R.S., "[t]he commission, at any time upon notice to the public utility affected ... may rescind, alter, or amend any decision made by it.

Any decision rescinding, altering, or amending a prior decision, when served upon the public utility affected, shall have the same effect as original decisions."

5. The Commission will grant the Motion to end the suspension of CPCN PUC No. 55779, and accordingly amend Ordering Paragraph Nos. 2 and 3 of Commission Decision No. C14-0079 pursuant to § 40-6-112, C.R.S., to reflect this change.

II. ORDER

A. The Commission Orders That:

1. The Motion filed by Heart of the Rockies Tours LLC to end the suspension of operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 557779 is granted as of the mailing date of this Decision.

2. On the mailing date of this Decision, CPCN PUC No. 55779 shall be administratively reactivated.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
