I. <u>BY THE COMMISSION</u>

A. Statement

1. This Decision schedules a technical conference for the purpose of deriving the approved increase in the electric utility base rate revenues of Black Hills/Colorado Electric Utility Company, LP (Black Hills) and the associated General Rate Schedule Adjustment (GRSA) for effect on December 27, 2014, following our deliberations on exceptions to Decision

No. R14-1298 issued October 28, 2014.

2. We direct Black Hills and the intervening parties that filed exceptions to Decision No. R14-1298 to participate in the session with Commission advisors. During the technical conference, Black Hills shall present its cost of service model, updated to reflect the Commission's findings and approved adjustments to its selected test year, as discussed during the deliberations held on December 10, 2014. Black Hills shall also present information on bill impacts associated with the approved rate increase in the manner typically used in advice letter filings.

3. Black Hills shall work with the intervening parties to resolve any discrepancies in

the cost of service model that relate to the application of the Commission's findings and

approved adjustments prior to the date of the technical conference. The parties will present

proposals for resolution for any remaining discrepancy issues at the technical conference.

4. Black Hills shall file the updated cost of service model, the GRSA calculation, the

Clean Air Clean Jobs rider calculation, and any other material to be presented at the technical

conference no later than December 16, 2014. Electronic executable files shall also be provided

to the Commission advisors.

5. The technical conference will be held before an Administrative Law Judge and it

will be an on-the-record proceeding.

1. A technical conference regarding the issues described above shall be convened as

follows:
