I. BY THE COMMISSION

- A. Statement, Findings, and Conclusions
- 1. On October 31, 2014 James Willson (Petitioner) filed a Petition for a Waiver of Rule 6308 (Luxury Limousine Categories) of the Rules Regulating Transportation by Motor Vehicle, 4 Code of Colorado Regulations 723-1.
- 2. The application placed the Petition on public notice for 30 days on November 3, 2014. An intervention was filed against the Petition on November 13, 2014 by Alpine and/or Go Alpine.
 - 3. On November 17, 2014, Petitioner filed a Withdrawal of the Petition.
- 4. Rule 1309(d) of the Commission Rules of Practice and Procedure, 4 Code of Colorado Regulations 723-1, permits a party to withdraw an application or petition upon notification to the Commission and all parties prior to 45 days before the first day of hearing. There is no hearing set on this Petition at this time.
