### I. <u>STATEMENT</u>

#### A. Background

1. Interim Decision No. R14-0769-I, issued July 7, 2014, set a prehearing conference in this proceeding for July 16, 2014.

2. On July 11, 2014, counsel for Respondent, Mountain Parks Electric, Inc. filed a Motion for Permission to Appear at Pre-hearing Conference by Telephone (Motion). According to the Motion, counsel requests to appear by telephone due to cost considerations.

Due to the disruptions of someone attempting to call into the hearing while it is in progress, co-counsel must call the Commission at the above indicated number no later than five minutes prior to the commencement of the pre-hearing conference in order to participate.

5. While counsel for Respondent failed to indicate whether he had conferred with counsel for the Complainants regarding the relief requested in the Motion, and failed to request a waiver of response time to the Motion, response time to the Motion will nonetheless be waived.

## II. ORDER

# A. It Is Ordered That:

1. The Motion of Mountain Parks Electric, Inc. for its legal counsel to appear at the July 16, 2014 pre-hearing conference by telephone is granted.
