I. <u>STATEMENT</u>

1. The captioned proceeding was initiated on July 16, 2014, when Charles Snyder (Complainant) filed a Formal Complaint (Complaint) against Randy's High Country Towing, Inc. (Respondent).

2. On July 23, 2014, the Public Utilities Commission (Commission) issued an order to Respondent to answer or satisfy the Complaint. At the same time, the Commission scheduled the matter for an evidentiary hearing for October 1, 2014 at 9:00 a.m.

3. Respondent failed to respond to the Order to Satisfy or Answer within the required 20-day period. As a result, on September 15, 2014, Interim Decision No. R14-1124-I

was issued which required Respondent to file an Answer to the Complaint. That Interim Decision also vacated the October 1, 2014 hearing date.

4. On September 17, 2014, Respondent filed its Answer to the Complaint.

5. By Interim Decision No. R14-1192-I, issued September 30, 2014, an evidentiary hearing was scheduled for November 10, 2014.

6. On October 7, 2014, Respondent filed a Motion for Extension of Hearing (Motion). Respondent requests that the evidentiary hearing be re-scheduled to a date after November 16, 2014.

7. Response time to the Motion expired on October 21, 2014. Complainant did not file a response to Respondent's Motion. As such, it is determined that Complainant does not oppose the request by Respondent to re-schedule the evidentiary hearing.

8. Good cause is found to grant the unopposed relief sought by Respondent. Consequently, the current hearing date of November 10, 2014 will be vacated and a new hearing date of Monday, November 17, 2014 will be set.

II. ORDER

A. It Is Ordered That:

1. The Motion of Respondent, Randy's High Country Towing, Inc. to vacate the current hearing date and set a new hearing date is granted.

2. The evidentiary hearing scheduled for November 10, 2014 is vacated
