#### (CORRECTED) STIPULATION

COMES NOW the Applicant, Brewhop Trolley, LLC (hereinafter "Applicant") and Intervenor Aspire Tours, LLC (hereinafter "Intervenor") and stipulate and agree as follows: The applicant amends the application to restrict as follows:

Transportation of passengers in charter service between points in the described portion of Larimer County, Colorado, shown on the attached Appendix A, on the one hand and points in Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson and Weld, State of Colorado, on the other hand.

Restricted to service originating at or destined to private residences, breweries, wedding venues, corporate offices and hotels and returning to the trip originating point.

Upon acceptance of this Stipulation by the Commission and amendment of the scope of authority sought by Applicant to restrict the authority sought as set forth above, Intervenor withdraws its intervention in this case.

East of a line beginning at the Wyoming-Colorado border on U.S. Highway 287, then south on U.S. Highway 287 to its intersection with North Taft Hill Road in Fort Collins, Colorado, then south on North Taft Hill Road to South Taft Hill Road, then south on South Taft Hill Road to North Wilson Avenue, then south on North Wilson Avenue to South Wilson Avenue, then south on South Wilson Avenue to is intersection with 14<sup>th</sup> Street SW, then west 14<sup>th</sup> Street SW to its intersection with County Road 21, then south on County Road 21 to its intersection with County Road 14, then west on County Road 14 to its intersection with County Road 23, then south on County Road 23 to its intersection with Colorado Highway 56, then east on Colorado Highway 56 to its intersection with North 95<sup>th</sup> Street, then south on North 95<sup>th</sup> Street to the Boulder County Line.

NOTE: North and South Taft Hill Road and North and South Wilson Avenue are in combination a continuous north-south road from U.S. Highway 287 to 14<sup>th</sup> Street SW in Fort Collins, Colorado.
