**I. BY THE COMMISSION**

**A. Statement**

1. This matter comes before the Commission for consideration of approval of one Corrective Action Plan (CAP) that was submitted by the metro Denver area Regional Transportation District light rail operation. The CAP is resulting from one derailment accident that occurred between the dates of January 1, 2019 and March 31, 2019. A report summarizing this CAP was filed by Staff of the Public Utilities Commission (Staff) on October 16, 2019. An additional CAP approved by the Commission in Proceeding No. 19I-0347R by Decision No. C19-0829 mailed October 11, 2019 is also included on the report for purposes of monitoring the CAP to closure and for a complete record of all CAPs that occurred during the January 1 to March 31, 2019 timeframe.

2. The CAP numbers reviewed by the Commission are:

CAP1-01152019 for final approval and monitoring to closure, and 19I-0347R for monitoring to closure.

3. The Commission has reviewed the summary report filed by Staff and concurs with Staff’s review of the CAPs and recommendations.

4. The Commission has jurisdiction in this matter under § 40-18-103, C.R.S., and Rule 7347 of the Rules Regulating Railroads, Rail Fixed Guideways, Transportation by Rail, and Rail Crossings, 4 *Code of Colorado Regulations* 723-7.

**II. ORDER**

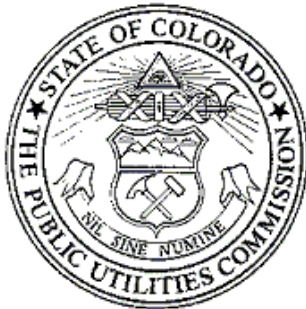
**A. The Commission Orders That:**
