1. The last sentence in paragraph 30 on page 11 of this Decision states:

Consequently, the ALJ extends the referenced deadline by 90 days, as permitted by § 40-6-109.5(1), C.R.S.

The 90-day timeframe is incorrect. The last sentence in paragraph 30 is corrected as follows:

Consequently, the ALJ extends the referenced deadline by 130 days, as permitted by § 40-6-109.5(1), C.R.S.

2. The first bullet point of ordering paragraph 5 on page 12 of this Decision states:
 - The hearing must be complete at least 94 days prior to the statutory deadline for a Commission decision to issue under § 40-6-109.5, C.R.S. (2018), unless Public Service waives the statutory deadline.

The statutory citation is incorrect. The first bullet point of ordering paragraph 5 is corrected as follows:

- The hearing must be complete at least 94 days prior to the statutory deadline for a Commission decision to issue under § 40-6-109.5, C.R.S., as amended by SB19-236, unless Public Service waives the statutory deadline.

3. Ordering paragraph 7 on page 12 of this Decision states:

Consistent with the discussion above, the deadline for a final Commission decision to issue is extended by 90 days, per § 40-6-109.5(1), C.R.S.

The 90-day timeframe is incorrect. Ordering paragraph 7 is corrected as follows:

Consistent with the discussion above, the deadline for a final Commission decision to issue is extended by 130 days, per § 40-6-109.5(1), C.R.S.
