- (C) Between the Fairfield Resort located approximately three and one-half miles west of Pagosa Springs, Colorado, on the one hand, and all points in the Counties of La Plata and San Juan, State of Colorado, on the other hand.
- (III) Transportation in charter service of

between all points in the Counties of Archuleta, Hinsdale, Mineral, and Rio Grande, State of Colorado, and between said points on the one hand, and all points in La Plata County, State of Colorado, on the other hand;

(IV) Transportation in sightseeing service of

RESTRICTIONS:

- (A) Item (II)(B) is restricted against providing service which originates (1) at points in the Counties of Hinsdale, Montezuma and San Juan, State of Colorado; and (2) at any point in La Plata County except for the La Plata-Durango County Airport.
- (B) Item (III) is restricted against the use of vehicles with a seating capacity of 32 passengers or more, excluding the driver.
- (C) Item (III) is restricted against providing service which originates at any point in La Plata County.
- (D) Item (IV)(B) is restricted to providing service between October 1 and April 30 of each calendar year.
