A. Statement

I.

This matter comes before the Commission for consideration of a letter submitted 1.

on July 14, 2020 by Ckimy LLC, doing business as iLimo (Applicant), requesting that the

Commission reopen the proceeding and allow an additional 30 days to comply with the terms of

Decision No. R20-0158 (Decision).

В. **Findings** 

2. On November 15, 2019, Applicant filed an application seeking authority to extend

operations under Certificate of Public Convenience and Necessity No. 55931.

3. The Commission noticed the application, pursuant to § 40-6-108(2), C.R.S., on

November 25, 2019. An intervention was filed on December 6, 2019 by Estes Valley Transport,

Inc., and the proceeding was referred to an Administrative Law Judge at the January 2, 2020

Commissioners' Weekly Meeting.

- 4. On March 11, 2020, the Decision was issued, granting the application as amended. In Ordering Paragraph No. 6, the Decision set forth certain requirements, such as having an effective tariff on file, that were to be completed within 60 days of the Decision's effective date.
- 5. By Decision No. C20-0316, issued on April 30, 2020 in this proceeding, exceptions were granted; and, the compliance deadline was extended until June 29, 2020. Applicant did not comply with all the requirements. Thus, the proceeding was closed without the extended authority being issued.
- 6. In the letter submitted on July 14, 2020, Applicant requests that the proceeding be reopened to allow an additional 30 days to comply with the Decision. Applicant explains, in part, the following: "On June 1st, Due to Covid 19, iLimo filed its first ever application to suspend all authorities for the safety of its employees and the public health. However, we did make the mistake of assuming since all authorities are suspended therefor all proceedings are."

## C. Conclusions

7. The Commission concludes that good cause exists to reopen the proceeding in order to extend the time for compliance with the requirements of the Decision for an additional 30 days.

## II. ORDER

## **A.** The Commission Orders That:

1. The letter filed by Ckimy LLC, doing business as iLimo on July 14, 2020, requesting that the Commission reopen the proceeding and grant an additional 30 days to complete the requirements set forth in Decision No. R20-0158, is granted.

- 2. Ckimy LLC, doing business as iLimo, is granted 30 days from the Mailed Date of this Decision to complete the requirements set forth in Decision No. R20-0158.
- 3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
  - 4. This Decision is effective on its Mailed Date.
