## INTERIM DECISION WAIVING RESPONSE TIME TO AND GRANTING MOTION FOR CLARIFICATION OF RECOMMENDED DECISION

### I. <u>STATEMENT</u>

1. By this Decision we grant the July 31, 2020 joint motion for clarification filed by United Power, Inc. and La Plata Electric Association, Inc. (collectively Movants) and waive response time to the motion.

2. Movants filed the motion seeking clarification of the current statutory deadline for a final Commission decision in these consolidated proceedings. As the Movants recognize, absent an extension of time due to extraordinary circumstances, the 210-day statutory deadline would end August 7, 2020.

3. The Administrative Law Judge (ALJ) addressed this issue at the April 14, 2020 prehearing conference. He issued an oral ruling on the matter,<sup>1</sup> finding extraordinary circumstances due to the ongoing Coronavirus pandemic and the tight timelines created by hearing Commissioner Frances Koncilja's term ending and the resulting rescission and referral to an ALJ. Based on those circumstances, the ALJ extended the statutory deadline by 90 days.

4. As a result, the statutory deadline for the Commission's final decision is November 5, 2020.

5. We also find good cause to waive response time to this motion under Rule 1308(c) of the Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1. The motion is unopposed by Tri-State Generation and Transmission Association, Inc., and clarifying this issue prior to the original deadline of August 7, 2020 will benefit all parties.
