I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On August 17, 2020, Home James Transportation Services Ltd., doing business as Home James, filed an application requesting that the Commission authorize the suspension of scheduled service operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 16114, from September 1, 2020 through November 19, 2020, due to the COVID-19 pandemic.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on August 17, 2020, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

- 4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the information submitted with this application warrants the granting of the requested partial suspension.
- 5. The application for authority to suspend the scheduled services under CPCN PUC No. 16114 is in the public interest and will be granted.

II. ORDER

A. The Commission Orders That:

- 1. This application was deemed complete on September 2, 2020, within the meaning of § 40-6-109.5, C.R.S.
- 2. The application filed by Home James Transportation Services Ltd., doing business as Home James, for authority to suspend the scheduled service portion of Certificate of Public Convenience and Necessity (CPCN) PUC No. 16114 is granted, *nunc pro tunc*, September 1, 2020 through November 19, 2020.
- 3. On November 20, 2020, the suspended portion of CPCN PUC No. 16114 shall be administratively reactivated.
- 4. Prior to commencing operations under the portion to be reactivated, Home James Transportation Services Ltd., doing business as Home James, shall ensure: (a) proof of insurance or surety bond coverage is filed with the Commission pursuant to Rule 6007, 4 *Code of Colorado Regulations* 723-6; (b) the applicable vehicle identification fee for each vehicle to be operated under authority granted by the Commission is paid; and, (c) an accurate and effective tariff and time schedule is on file with the Commission, in compliance with applicable Commission rules.

- 5. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
 - 6. This Decision is effective on its Mailed Date.
