I. <u>BY THE COMMISSION</u>

A. Discussion

1. On October 1, 2021, in Decision No. C21-0610, the Colorado Public Utilities Commission (Commission) issued a Notice of Proposed Rulemaking (NOPR) to amend the Commission's Rules Regulating Gas Utilities, 4 *Code of Colorado Regulations* (CCR) 723-4 (Gas Rules). The proposed amendments would add to as well as revise the existing provisions of the Commission's Gas Rules in seven areas: (1) the General Provision rules at 4 CCR 723-4-4000 *et seq.*; (2) the Operating Authority rules at 4 CCR 723-4-4102; (3) the Facilities rules at 4 CCR 723-4-4210 (Line Extension Rule); (4) the rules governing calculation of Greenhouse Gas Emissions (Greenhouse Gas Emissions Rules) at 4 CCR 723-4-4526 *et seq.*; (5) the rules governing Gas Infrastructure Planning at 4 CCR 723-4-4550 *et seq.* (GIP Rules); (6) the rules governing Clean Heat Plan at 4 CCR 723-4-4725 *et seq.* (Clean Heat Plan Rules); and (7) the rules governing Demand Side Management at 4 CCR 723-4-4650 *et seq.* (DSM Rules).

- 2. By Decision No. C22-0427, mailed on July 22, 2022, the Commission issued an Interim Decision and accompanying updated redlined rule provisions (Revised Redline) and scheduled a continued rulemaking hearing on August 9, 2022 and September 19, 2022.
- 3. This Decision gives guidance to the prospective participants in the public comment hearing scheduled for September 19, 2022 beginning at 9:00 a.m.
- 4. Participants may organize their oral comments in the manner and scope they find appropriate. However, the Commission anticipates tentatively organizing the discussion in the following matter. We anticipate this organization will assist in furthering commenter dialogue, such that the discussions may best add to the robust record in this matter. The Commission will move through topics in this order, but will begin the next topic area once completed with the last (*i.e.*, if the first hour of public comment ends early, we will move to the discussion regarding line extensions when complete).

later than October 4, 2022.

B. **Findings and Conclusions**

6. We find good cause to schedule a public comment hearing to receive oral comments

on the Gas Rules. The public comment hearing will be held on September 19, 2022, using the

web-hosted video-conferencing service Zoom. Participants in the hearing should prepare in

advance to use this platform. For those who wish to provide oral comments during the hearing,

video-conference participation is preferred. The link, access code, and call-in information to

 - 8. The hearing will begin at 9:00 a.m. on September 19, 2022.
- 9. Signing up prior to the hearing is not required to provide oral comment at the hearing. building containing the Commission's offices and hearing rooms is closed to the public.

6. Interested persons may participate in the public comment hearing by telephone or

video-conference using the information provided in this Decision.

7. When joining the public comment hearing, participants are required to enter their

full name when prompted to do so through Zoom.
